## ORDINANCE NO. 4 SERIES 1998



## AN ORDINANCE TO PROVIDE FOR REGULATION OF PEDDLERS IN THE VILLAGE OF JOY, ILLINOIS

BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE VILLAGE OF JOY, ILLINOIS, THAT:

SECTION 1: LICENSE REQUIRED: No person shall hereafter within the corporate limits of the Village exercise the calling or occupation of a hawker or peddler without a license therefor, first obtained and paid for as hereinafter provided.

SECTION 2: DEFINITION: Any person who shall peddle from house to house, sell or offer for sale, barter or exchange, any goods, wares or merchandise, patent invention or device, or other article or thing in the Village, or at, in or upon any street, avenue, alley, sidewalk or other place within the corporate limits of said Village, shall be deemed to be a hawker or peddler.

SECTION 3: APPLICATION ISSUANCE: All licenses granted as hereinbefore provided shall be issued by the Clerk on application of the person to whom the same is to be issued or his agent, and payment of the amount required by this Chapter for the full time for which such license shall run. Each license so granted shall be issued by the Clerk and bear the Corporate Seal of the Village. This Ordinance shall not apply to wholesale dealers.

SECTION 4: CONTENTS OF LICENSE: Every license granted in pursuance of the provisions of this Ordinance shall express therein the name of the person or persons to whom the same is granted, the manner in which the articles so offered for sale are carried or conveyed; the kind, name or nature of the goods, wares, merchandise, patent invention, device or other thing to be sold or peddled, together with the date of issuing said license, and the time when the same will expire.

SECTION 5: LICENSE NONTRANSFERABLE: No license granted in pursuance hereof shall be assignable or transferable, nor shall any such license authorize any person to do business, or act under it, except the person to whom, and in whose name the same shall have been granted; nor shall any person by virtue of a peddler's license carry on his business at any place, or in any other manner than as defined herein.

SECTION 6: APPLICATION FEE: All applicants for a Peddler's License set forth herein shall be required to pay a fee of \$25.00 simultaneously with the filing of their application.

SECTION 7: REVOCATION: Whoever shall violate, neglect or refuse to comply with and conform to the provisions of this Ordinance shall be subject to a penalty as in this Ordinance provided, and a like penalty for every day during which such person or persons shall continue in violation hereof; and his license may in the discretion of the President of the Board of Trustees/Mayor, be revoked.

SECTION 8: TIME LIMITATION: The licensee hereunder shall be allowed only to solicit during the hours of 8:00 a.m. to 4:00 p.m., each day during Central Standard Time, or 8:00 a.m. to 6:00 p.m., during Daylight Savings Time.

SECTION 9: PENALTIES. Any person violating any of the provisions hereof shall be guilty of a misdemeanor, and upon conviction thereof shall be fined in an amount not less than Seventy-five (\$75.00) Dollars, nor exceeding Two Hundred (\$200.00) Dollars for each violation. Each day in which such violation shall continue shall be deemed a separate offense.
