ORDINANCE NO. 7, SERIES 2015

VILLAGE OF JOY, COUNTY OF MERCER, STATE OF ILLINOIS

An ordinance prohibiting compression release engine braking in the Village of Joy, Illinois.

WHEREAS, the Village Board has determined that excessive noise within the Village of Joy, Illinois created by compression release engine braking by motor vehicles so equipped has been an annoyance and nuisance to the residents of the Village and the general public, and to deter disruption of the general peace, compression release engine braking is shall be prohibited within the Village;

NOW, THEREFORE, BE IT ORDAINED BY THE VILLAGE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF JOY, MERCER COUNTY, ILLINOIS, AS FOLLOWS:

- **SECTION 1.** No person shall operate or cause to be operated at or upon any public highway located within one thousand (1,000) feet of any area of the Village of Joy, Illinois that contains any single-family or multi-family dwelling units, any compression engine brake on any vehicle for any reason. For purposes of this section, a "compression engine brake" is defined as any mechanical exhaust device designed to aid in the braking or deceleration of any vehicle by converting engine power to compressed air which results in additional, excessive, loud, or explosive noise from such vehicle.
- **SECTION 2.** Any person found to be in violation of this section shall be subject to a fine of not less than seventy-five dollars (\$75.00) and not more than seven hundred fifty dollars (\$750.00).
- **SECTION 3.** All ordinances or parts of Ordinances in conflict herewith are hereby repealed.
- **SECTION 4.** The Village Clerk is authorized and directed to publish this Ordinance in pamphlet form.
- **SECTION 5.** This Ordinance shall be in full force and effect upon its passage and publication as provided by law.
