REGULAR BOARD MEETING MINUTES

Wednesday December 20, 2023

The Regular Meeting of the Joy Village Board was called to order at 5:30 p.m., Wednesday December 20, 2023 by Village President Larry Hunt. The meeting was held at Village Hall, 200 West Main Street, Joy, IL.

Pledge of Allegiance

Roll was called by Village President Larry Hunt.

Trustees present: Kristy Lee, Paul Hampton, Patsy Peterson, Jason Huston, Noah Livermore Village Trustee Rory Conway was absent. Village Trustee Noah Livermore arrived at 5:40 p.m. Gwen Pritchett-Village Clerk was present.

ION was not present for the meeting.

Village President Larry Hunt discussed the ION Report-Lead and Copper tests are done for the year. The well has been running good. Britton made some adjustments at the site and there are no longer issues with faults and failures. They will still install a small line filter, which is on order and will be installed when it arrives. There is an issue with the transducer that reads the level in the brine tank. It will be fixed. A part will be purchased for around \$20 or so. It is thought that the line is full of sediment from the tank and is causing the transducer to read incorrectly sometimes. Seems to be more of an intermittent issue.

Wastewater System- Nothing to report.

IRWA Rate Study for the Village of Joy's water and sewer rates were reviewed and discussed. IRWA's suggestion was to raise the water rate and repair all non-operating meters and undertake a leak detection survey to help locate any unknown leaks. It was discussed not to raise rates but work on the problems with meters and leaks then do another Rate Study next year. There are some meters in pits that do not work and there are some that do not have meters at all. Village Trustee Noah Livermore discussed the meters in pits, and the cost of a new pre-cast pit will be around \$8,000 each. There may be other pit options that will cost less. Will discuss at a later date. Village of Joy has extra meters in stock. Village Trustee Noah Livermore asked it the water is metered when it comes out of the treatment plant. Village President Larry Hunt recommended installing working meters at all homes and businesses. When sold to residents, meters are sold at cost.

Addition to the Agenda: Village Trustee Noah Livermore discussed purchasing a used jetter from the City of Aledo. The City of Aledo will surplus their 350 ft. pull-behind jetter when they purchase a new one.

Village Trustee Noah Livermore made the motion to purchase the City of Aledo's surplus jetter not to exceed \$800.00. Patsy Peterson 2nd the motion. The following vote was taken: Kristy Lee-yes, Paul Hampton-yes, Patsy Peterson-yes, Jason Huston-yes, Noah Livermore-yes. The motion was passed with a unanimous "Yes" vote.

Motioned by Village Trustee Noah Livermore to go into executive session at 6:09 p.m., to discuss real estate and police personnel. Paul Hampton 2nd the motion.
