REGULAR BOARD MEETING MINUTES

Wednesday, June 19, 2024

The Regular Meeting of the Joy Village Board was called to order at 5:30 p.m., Wednesday June 19, 2024 by Village President Larry Hunt. The meeting was held at Village Hall, 200 West Main Street, Joy, IL.

Pledge of Allegiance

Roll was called by Village President Larry Hunt.

Brian Glasgow/ION addressed the Joy Village Board. 3E serviced the Village of Joy generators last week. The sewer leak at Kevin Ortberg's grain bins was fixed. The problem was a pressure relief valve. Electric Pump does not bid jobs. Advanced plumbing prices are \$112 and hour per person, for 2 people, \$280 per hour for the truck. The project may take 3 hours. Brian likes working with Electric Pump. The information was enclosed in the board packets for this meeting. After discussion, Village Trustee Noah Livermore made the motion hire Advanced Plumbing at \$112 per hour per person and \$280 per hour for the truck. Rory Conway 2nd the motion. Brian Glasgow will make arrangements with Advanced and Electric Pump for lift station work. Brian left the meeting at 5:40 p.m.

Village President Larry Hunt items of discussion: The Village of Joy could use a ditch bucket for cleaning out ditches. A ditch bucket is more narrow- v shaped bucket. Village President Larry Hunt asked the Village Board of Trustees to consider purchasing a ditch bucket. Village Trustee Noah Livermore suggested getting bids.

The Village of Joy is waiting on paperwork to close Alley-Penn to Washington.

Trayton Whitmire was unable to at attend tonight's meeting, so Josh Hicks discussed Trayton's alley way with the Village Board. At the end of the alley behind Trayton's house, it is all torn up from people driving through the alley when it is soft after it has rained. Village President Larry Hunt asked Josh Hicks to fill in the ruts with fill dirt and rock on top. Old fill dirt will be used for this project. Village Trustee Patsy Peterson said all of the people that have yards that are connected to that alley mow and maintain the alley.

The City of Aledo is going to accept sealed bids for their jetter. Not sure when this is going to happen. Will try to get more information.
